ORGANIZATIONAL MEETING – OCTOBER 5, 2021

THE ORGANIZATIONAL MEETING OF THE COUNCIL OF THE VILLAGE OF YOUNGSTOWN WAS HELD IN THE MUNICIPAL OFFICE ON OCTOBER 5, 2021 AT 5:40 PM.

PRESENT WERE ROBERT BLAGEN, KEN JOHNSON, DEBBIE LAUGHLIN AND ADMINISTRATOR EMMA GARLOCK.

THE ADMINISTRATOR CALLED FOR THE ELECTION OF MAYOR FOR THE CURRENT TERM. MOVED BY MR. JOHNSON THAT MR. BLAGEN BE NOMINATED FOR THE POSITION OF MAYOR. MS. LAUGHLIN MOVED NOMINATIONS BE CEASED. CARRIED UNANIMOUSLY. THE ADMINISTRATOR ASKED MR. BLAGEN IF HE WOULD LET HIS NAME STAND. MR. BLAGEN SAID HE WOULD. MR. BLAGEN WILL BECOME THE MAYOR.

MR. BLAGEN SIGNED THE OATH FOR OFFICE AND TOOK OVER THE CHAIR.

MOVED BY MR. BLAGEN THAT MR. JOHNSON BE NOMINATED FOR DEPUTY MAYOR. MS. LAUGHLIN MOVED NOMINATIONS CEASED. CARRIED UNANIMOUSLY.

MR. JOHNSON SIGNED THE OATH FOR OFFICE OF DEPUTY MAYOR.

MS. LAUGHLIN SIGNED THE OATH FOR OFFICE OF COUNCILLOR.

MOVED BY MS. LAUGHLIN THAT THE REGULAR MEETINGS OF COUNCIL BE HELD ON THE FIRST TUESDAY OF THE MONTH, EXCEPT FOR HOLIDAYS, THEN THE SECOND TUESDAY. CARRIED UNANIMOUSLY.

MOVED BY MR. BLAGEN THAT THE BANKING CONTINUE TO BE WITH THE TREASURY BRANCH IN HANNA, ALBERTA. THE SIGNING OFFICERS ARE TO BE TWO OF THE FOLLOWING: ROBERT BLAGEN, KEN JOHNSON, DEBBIE LAUGHLIN AND EMMA GARLOCK. CARRIED UNANIMOUSLY.

THE ADMINISTRATOR WILL TRY AND HAVE INFORMATION FOR THE ELECTED OFFICIALS TRAINING AT THE NEXT COUNCIL MEETING.
