October 5, 2021 – Regular Session**

Council of the Village of Youngstown met in Regular Session in the Village Office on October 5, 2021. The meeting was called to order at 4:00 PM.

Present were Council members Ms. Laughlin, Mr. Johnson, Mr. Blagen, Administrator Mrs. Garlock, ECR reporter Terri Huxley and virtually Jennifer Koppe & Paul Conrad from Studio 818 and Mark Nikota from CCEDC.

Ms. Koppe and Mr. Conrad updated Council on what they heard at the community engagement for the community development project. The feedback was very informative and positive. Council would like them to focus on the Main Street project ideas.

Returning Officer Mrs. Garlock has appointed Mrs. Marilyn Johnson as the Substitute Returning Officer and Ms. Debbie Laughlin as the Deputy Returning Officer for the upcoming Senate Election and Referendum. Mr. Blagen moved to pay each worker \$360 for working the election. Ms. Laughlin abstained from the vote. Seconded by Mr. Johnson. Carried.

Ms. McNiven will not be able to be the auditor any longer. Mrs. Garlock will contact a couple other municipalities and advertise the position.

It is a great honor to announce that Mr. Blagen has been chosen to receive the prestigious AUMA Distinguished Service Award. Mr. Blagen will attend the ceremony in Edmonton on November 18 along with Mr. Johnson, Ms. Laughlin and Mrs. Garlock.
